

Terms and conditions of participation in the 'Refer a customer' campaign

1. General information

Customers of autosen gmbh may participate in the 'Refer a customer' campaign in accordance with these terms and conditions of participation and recommend the services of autosen gmbh to third parties who have not yet been or are not currently customers of autosen gmbh ('new customers').

2. Eligibility

Only existing customers of autosen gmbh who have successfully completed and paid for at least one (1) order are eligible to participate.

Participation is only open to persons of legal age with full legal capacity.

3. Bonus for successful referrals

For each successful referral, the referrer will receive a bonus in the form of a voucher worth 50€/ 50\$/ £50, which will be sent by email to the address stored in the customer account after the referral has been successfully verified. A referral is considered successful if the referred person has completed and paid for an initial order within 30 days of registration.

A voucher:

- is valid for four (4) weeks from the date of dispatch,
- can be redeemed for a minimum order value of 150€/ 150\$/ £150 (one-off),
- cannot be combined with other promotions,
- is non-transferable, and
- cannot be exchanged for cash.

Only one voucher can be used per order.

The referrer will receive only one (1) reward per new customer referred.

The referred customer will also receive a one-time voucher worth 50€/ 50\$/ £50 in accordance with these terms and conditions.

After successful registration and initial order, the referred customer can then participate as a referrer themselves.

Multiple referrals of the same new customer are not permitted.

The promotion is only valid for new customers.

4. Consent of the referred person

Participation requires that:

1. the referred person is personally known to the referrer, and
2. the referrer has obtained the express consent of the referred person to pass on their contact details before making the recommendation.

By participating, the referrer confirms that this consent has been obtained.

Advertising contact (e.g. by e-mail, SMS or messenger) without the express consent of the referred person is not permitted (§ 7 UWG).

5. Data protection

Within the scope of the campaign, personal data of the referrer and the referred person will be processed exclusively for the purpose of carrying out the campaign.

The responsible party is **autosen gmbh**, Annastrasse 41, 45130 Essen, Germany.

The legal basis is Art. 6 (1) lit. b GDPR (performance of a contract) or Art. 6 (1) lit. a GDPR (consent).
